

Live Trading Competition

Terms & Conditions

The below outline the Terms and Conditions for the Live Trading Competition organized by Streams Global Markets LLC (“the Company”) in partnership with Trading PRO, as these may change from time to time and should be read in conjunction with the Company’s General Terms & Conditions. In case of discrepancy between the two, these terms prevail.

Streams Global Markets LLC, in partnership with Trading PRO, offers to its new and existing customers (the “Participant”), for a limited time only, the opportunity to win attractive rewards by participating in the Live Trading Competition.

Bonuses and/or financial awards or promotions (“Award”) rewarded to Customers are part of the Company’s promotional program. The following terms shall apply in reference to the relevant Customer Account (“Account”).

Disclaimer: Bonuses and awards are not available to Customers residing in a banned/not permitted jurisdiction. If credited, the bonus will be removed from accounts of Customers from the aforementioned countries. The Company reserves the right to determine the countries falling under the “banned/not permitted” category.

By entering in this Competition, the Customer hereby agrees to abide by the below terms and conditions:

1. Eligibility criteria

To qualify for this Competition, the Participant must fulfil the following criteria:

- The Participant shall be an existing or new Client and meets the Company’s appropriateness requirements.
- The Participant shall fund its account before the start of the competition with a minimum amount of Two Hundred United States Dollars/Euro (200 USD/EUR).
- Existing Clients can participate in the Competition by opening an additional account for the purposes of the Live Competition and make a fresh deposit as indicated herein.

Registration and Trading Period

- The live trading competition starts on 15th July 2021 and ends on 30th September 2021.
- The Company reserves the right, at its sole discretion and without prior notice, to extend the promotional period.
- The Client if wishes to participate in the Live Trading Competition shall register on the dedicated page.
- All participants in the competition should provide a nickname to be used for ranking purposes ONLY.

- The selection of the winners will be done at the end of the Competition period and will be announced publicly on the Company's (and its affiliates') website and via email to the winners within ten (10) days from the completion of the Live Competition.

The winner shall be that Participant who realized the highest equity value by 30th September 2021 as per below formula:

Return All Time +Return Month*1.5 + Daily Return Volatility* 0.5

- Participants are eligible to the Competition if they operate a minimum of 20 trades with a minimum accumulative volume of 1 lot per natural month and trade 3 lots during the entire Competition's period (15/07/2021 to 30/09/2021)

At the end of the Competition, 3 (three) Participants will be rewarded, as detailed below:

- a. The Live Trading Competition Winner shall receive One Thousand United States Dollars (1,000 USD);
 - b. The Runner up shall receive a prize of Seven Hundred Fifty United States Dollars (750 USD);
 - c. The 2nd Runner up shall receive a prize of Five Hundred United States Dollars (500 USD).
- Prizes shall be awarded in USD value in the same trading account used by the Participant throughout the competition, in the form of a credit.

Prize Withdrawal

In order for the Winners to be eligible to withdraw their Awards, the winners must execute a minimum trading volume of 5 lots with minimum 5 minutes in the market for each position.

The Award will be made available for withdrawal only if the required trading volume has been achieved in its entirety and has to be claimed within 3 months from the time of receiving the credit into the trading account. Generating a partial amount of the required trading volume does not grant the ability to withdraw a partial amount of the Award.

Should the Customer withdraw any funds from the Account before completing the required trading volume, the total Award amount may be deducted from the Account. The Customer's trading volume in the Account will be calculated from the date the Customer receives the Award.

Miscellaneous

The use of Expert Advisors or Robot software for automatic trading is NOT allowed. The Participant that will use those tools can and will be excluded from the Competition.

- If Streams suspects or has reason to suspect that a Participant has abused the fair rules of the Live Competition by hedging his positions internally (using other trading accounts held with Streams) or externally (using other trading accounts held with other brokers), then Streams reserves the right to immediately disqualify the Participant/Client from the Live Competition without the consent of the Client.

If any provision of this Agreement is held invalid or unenforceable, such invalidity or unenforceability shall not affect the other provisions of the Client Agreement, and, to that extent, the provisions of this Agreement are intended to be and shall be deemed severable;

The Company reserves the right to allocate or decline any bonuses or awards at its own discretion.

Acknowledgements

- The Participant hereby acknowledges and authorizes Streams to announce the weekly results of the Live Competition on its website. Ratings are calculated considering multiple factors: initial deposit, trading volumes, rentability, etc., in form of Rating Points available in the official website page of the Competition.
- The Participant hereby acknowledges and agrees that the maximum leverage shall be set to 1:500, and minimum leverage set 1:100.
